Professor Porter says that:

“Economic policy and social policy have been largely separate agendas, involving different participants. Many see the two as conflicting agendas. However, there is no inherent conflict between capitalism and social needs. A productive and growing economy requires rising skill levels, a proliferation of new companies, safe working conditions, healthy workers who live in decent housing in safe neighborhoods, and a sense of opportunity. Social and economic policy must be integrated in addressing society's ills and ensuring true progress”.

By conferring on our partnership, this encouragement award, I believe the Prime Minister has identified a community and business partner that is attempting to do just that.
